2016/2017 ANNUAL SERVICE APPLICATION

Storm Water **\$750.00**

To be involved in our storm water service program, you must have filed or be prepared to file a Notice of Intent with the State Water Resources Control Board. The billing for this program includes an initial administration fee of \$750 plus end-of-the-year-billing for the number of samples collected at your facility. The administration fee covers direct costs for one site visit per year to your facility and report review time plus shared costs for travel and regulatory liaison services. The cost per sample is \$115.

On July 1, 2015 the new permit - Order NPDES NO. CAS000001 for Storm Water Discharges become effective superseding the previous Order 97-03-DWQ. There are changes in the new permit that will impact CGFA Storm Water participants. A SWWP, NOI and additional monitoring and sampling are required in the new permit. In order to assist you in your preparation for the changes CGFA Services will be offering additional services that are outside the current program; fees for these services will vary by site.

- NOI preparation varies by site, request quote
- SWPP Preparation \$500 - \$2000, fee will be based on the site, request quote
- Additional site visitvaries by site, request quote
- 2015 SPPP Template\$500.00

All of the above prices are for one facility and include travel expenses if the facility is located within one hour's driving time from Sacramento. If the facility is located outside the travel radius, additional travel will be charged at \$50 per hour. Please note that the association's policy is to minimize travel expenses to the extent possible.
